



Jesus said, "Do not worry about your life, what you will eat; or about your body, what you will wear...Consider how the lilies grow. They do not labor or spin. Yet I tell you, not even Solomon in all his splendor was dressed like one of these. If that is how God clothes the grass of the field, which is here today, and tomorrow thrown into the fire, how much more will he clothe you! But seek first God's kingdom, and these things will be given to you as well." Luke 12:22-31

It was during our seminary years, working two part-time jobs with three young children under age five when Karen and I first set a conscious goal to give a full tithe. At the time, I must admit that it was a scary goal to reach for. And yet, what we had come to learn over our lives was that no matter how much we gave, we could never outgive God. While I don't recall if we made that goal at first, but ever since, we have striven to give at least at that level each year. It takes discipline, planning, and trust. We do our part of setting aside the resources we plan to give and then we trust that God will take care of the rest. And here is what we've found, time and time again, God continues to shower us with his blessings, more so than we could ever need. So we never have to worry.

In the scripture above, Jesus was approached by one of his followers who demanded that he settle a dispute with a brother over receiving his fair share of the inheritance. While we don't know the context behind this man's ask, Jesus chose to take it in a completely different direction. He focused on the man's worry and lack of trust in his heavenly father.

You see this man was worried that he might be treated unfairly by his brother. Never once does it seem that he considered how his heavenly father would take care of him despite the outcome. This is why Jesus told him, don't worry about your life, but consider how God lavishly cares for birds of the air and the flowers of the field. If God cares for them, provides for them, and they worry not, then God will care for you as well.

My friends, that is so true in this season of stewardship. We boldly ask the people who consider Cascades to be their home church to establish the discipline of tithing, to come up with a plan for how they will do that, and then to trust that God will take care of the rest. SPOTLIGHT ON OUR MEMBERS

Born Christmas day on a Warren, PA, dairy farm, anticipating many milked cows, he later attended Rocky Grove High School. Then, at age 17, he joined the Navy, serving for eight years. Naturally, he saw the world, visiting too many places to mention! He apprenticed as an ejection mold maker and machinist, leading to his career in that field. At age 43, he joined the Air Force Reserves for 17 years, retiring as a Master Sergeant. Life brought him to Ohio, Texas, Oklahoma, Colorado, California, Idaho, Arizona, New Mexico, Utah, and finally to Boeing in Washington employed in Research and Development.



She, the 13th of 14 children, born and raised on a farm in Spangle, WA, near Spokane. She regularly milked two cows, lived with her sister before graduating from Rogers High School, and left home at age 18. Subsequently, she moved 26 times! Home has been in Washington, California, Illinois, Montana, and in and out of California several times and back to Washington for the last 51 years. She attended Eastern Washington University for one year, then modeling school in Seattle. From the age of 11 she has loved to sew. Ever after, she sews and alters every chance she gets!

She found employment as a model on runways and in tea rooms and as a stewardess for Western Airlines ("the only way to fly!" as she traveled the West Coast, Mexico, and Canada). Over the years of raising four children, Laura took care of pets: hamster, guinea pig, tree crab, and many cats and dogs. Joe also has cared for dogs and cats. Joe has three children from a previous marriage, including one daughter who passed at age 60.

GIVING GENEROUSLY

In this season of giving, there are many ways that you can help Cascades carry forward its ministry and mission. You could consider making a charitable stock in-kind gift directly transferred to Cascades. This avoids any capital gains while maximizing your charitable deduction for the full value of the security. If you need help with that, the Presbyterian Foundation or your stock broker can assist with details of the stock transfer.

You could set up a Donor Advised Fund through the Presbyterian Foundation. These funds are opened with a minimum of \$2500 where the donor directs grants in minimum increments of \$100 to charities of their choice. Note that this sort of giving cannot be used to satisfy annual pledges however.

You could give annual gifts to the church from your traditional IRA and NOT from your checkbook. This is especially true for people over age 73 who must take required minimum distributions (RMDs) from their IRAs. Gifts from traditional IRAS through RMDs are considered Qualified Charitable Distributions which do NOT count towards a person's taxable Adjusted Gross Income and can be given annually up to \$100,000. The Presbyterian Foundation strongly advised that giving through Qualified Charitable Distributions is the smartest way for people over 70 to give charitably.

And finally, you could consider how you might like to give to Cascades through bequests such as wills, life income gifts, retirement accounts, or charitable lead trusts.

FALL STEWARDSHIP CAMPAIGN

Each fall your session elders consider the ministry they feel called to for the following year and create a proposed budget of what they expect that ministry to cost. From that we generate a narrative budget brochure which highlights snapshots of the congregation, any changes we anticipate, and the impact that these funds have in our church and surrounding community. Along with these brochures are white planned giving cards which detail how much you and your family will prayerfully pledge or tithe to the church. We will receive these cards in worship on Sunday November 3. For those who worship online, if you would mail those cards in, that would be greatly appreciated. We always strive for 100% return of the cards whether or not people are able to make commitments at this time. If you have any questions, please do not hesitate to reach out to one of your session elders.

OCTOBER SESSION NOTES

Laura Livingston, Elder of Worship Arts, led a devotion that got us to ponder "what is worship to us?" Some thoughts are that it is both now and yet to come. It includes both heaven and earth. It is more than just music. Engages all five senses (sight, hearing, touch, taste, and smell). Is incomprehensible. Involves the great cloud of witnesses, both saints here and those who have gone ahead of us into glory. Treasurer reports that income and expenses were balanced for this time of year. Reviewed the Fall Stewardship Narrative Budget Draft to be sent out the congregation. Interviews for the Office/Administrator/Bookkeeper were under way. Planning to steam clean chairs in sanctuary at end of October. Looking at adding music from new Presbyterian Glory to God hymnal to worship service. Discussed plans for Presbyterian Churches of Clark County Thanksgiving Week Service, Michelle Drexler's retirement party on December 8 following worship, and a Longest Night Worship Service for those who are grieving during the Holidays. Spent time praying for those in our congregation who are sick and those who have been affected by the back to back hurricanes in Florida.

WHAT TO DO IF SOMEONE HAS FALLEN

Unfortunately people fall. They trip or are accidentally shoved or they faint. What should we do when that happens? Here are safe and effective ways to help a person who has fallen.

- 1. See if the person is in pain. Look for visible injuries or facial grimaces.
- 2. If you do not notice or find injuries and the person thinks they can get up, place a sturdy chair directly in front of them or ask them to crawl to the nearest stable piece of furniture.
- 3. Let the person use the chair, first to get into a kneeling position then partially stand. Gently guide them if necessary.
- 4. If they are unable to kneel or stand help them get up slowly and sit in the chair.
- 5. Once they are seated look again for injuries.

IF THE FALLEN PERSON IS INJURED OR UNABLE TO GET UP CALL FOR MEDICAL ASSISTANCE IMMEDIATELY. Sometimes when a person has fallen they are embarrassed and want to get up right away. Caution them to sit for a minute so they can get their bearings and then follow the procedures above.




